

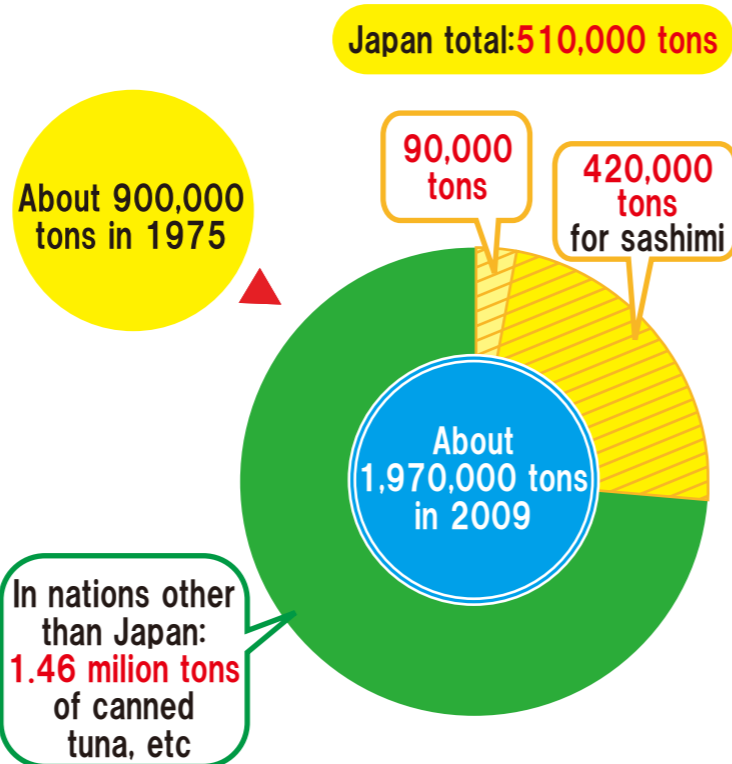

### World tuna supply and the Japanese market

Expansion of tuna production and supply to the world and Japanese market



Japan is the world's largest consumer of tuna.

Japan consumes one third of the global tuna catch, mostly for sashimi. The international community expects Japan to fulfill its responsibilities for conservation and management of tuna resources.



### International Treaty on Tuna Fisheries (Management Organizations)



Tunas are highly migratory fish species. The United Nations Convention on the Law of the Sea (UNCLOS, 1984), calls on the States to cooperate directly or through appropriate international organizations to ensure conservation and promoting the objective of optimum utilization of the tuna species throughout the world.
